- a My mother is sure of the time. She called twice.
- q what about the conversation?
- a She told my mother she was sleeping over her friend's house Christine and she would see my father tomorrow because it would be his birthday.
- q that was the last phone call.
- a yes.
- q that was the last anybody heard from her?
- a from Marie personally.
- q you went to David Doyle's house.
- a At 6:45 in the morning my mother came to my house. She told me what she heard. She did not know where Marie lived. I took over Marie and Dave's old apartment. They had moved to Jeffrey. I knew where it was. We went there

g did you notice scratches on his hands?


a I did I noticed them because as my father talked to him his hands were under his legs.
