- q did you know Marie Iannuzzi?
- a very well.
- q how long did you know her?
- a 6 to 7 years.
- q do you know David Doyle?
- a yes.
- q how long have you known him?
- a about 4 years.
- q some point in time did you learn about Marie's death?
- a I was informed by 2 of my girlfriends who came by my house. They heard it on the news to inform me.
- q was it the day after the body was found?
- a the day it was on the news.
- q do you know anything about the relationship?
- a She loved him. She referred to him as my Dave. She went through a lot with him. He was in and out of the detention center. He was in some kind of hospital, it was like a VA Hospital I am not too sure. They had fights like every normal couple. Marie used to call me ma. I am 30 she was younger.

 One day she called me she said my Dave almost killed me I said what are you talking about. She said he strangled me he scared me. I said get your

clothes and come down stay at my house. She told me that she was staying at Chris's house.

- q who is that?
- a Chris Delisi and she said she would come. She moved later on she stayed with me for one hour she said she was going back to Chris' house.
- I said did he really strangle you she said I don't want to go. She had long red marks on her neck.
- q you saw them.
- a yes.
- q no doubt about that?
- a like long red marks like fairly long(indicating),
- q indicating both sides of the neck?
- a Yeş she got in a fight with Dave I said what happened she said a big argument we got in first fight he tried to strangle me.
- q when was this?
- a summer time between May and June I think, I remember more toward May than June.
- q this was May and June preceding her death in August?
- a yeş before she died.
- q did she eventually go back to him?
- a As far as I know she stayed at Chris' house for a week then said she was going to her mother's. I don't know when she went back to Dave but she did go back to Dave.
- q when was that can you try to rememember?
- a It was warm her birthday was June 25 my birthday was June 20 we celebrated on her birthday it was more like that.

q anything else you can add, did you see David Doyle?

a I saw him at the wake. He looked like he was high. I was there every night I never saw him go to the coffin to visit her. The day she was buried I was looking for him. We went to Florida together. She lived with me for a while. We talked a lot. She really loved him a lot. She tried protecting him a lot. At most times they had a fight when Dave was high. He used to use Valium and smoked Dust.

q how do you know?

a I saw him take it once My sister used to take Valium. She almost died.

q did you ever see him like that?

a quite a few times.

q you knew he took Dust before.

a yes.

jq were you at the wedding?

a no.

jq did she take drugs?

a She had Dust and Valium. She tried getting him off it I think that is the reason he was in that type of hospital. She said I wish he would get off it. She did not mind if he smoked regular pot but it was the Dust and Valium, she was happy when he was in this hospital.

jq was it a Rehab under the V.A?

a I don't know I believe it was a VA Hospital and a secured jail type thing.

You needed a pass to get in. They were helping him to try and get off.

jq do you know where the hospital was?

a I think Brookline.

jq you were with the family all during this from the time they knew about

ie an hrough the wake and funeral at any time did you see him at the wake?

a First night I went there he was outside on the sidewalk at the funeral parlor. I walked to the door. He went to kiss me on the cheek. His eyes were like he was in a trance. He went to walk to the door with me. He was wobbly I went upstairs where Marie as. I stayed in the back of the room ever night I was there I never saw him go to the coffin to visit Marie. jq did you see Mr. Puzzo the uncle at the wake?

a I don't know him by name.

q did you see Mr. Puzzo at the coffin?

a The one I was watching was the mother. They were supporting her. She was trying to touch her daughter's face and I was sitting with the sister Marie had this thing she was never pretty.
