- q what did you observe about his person?
- a He came to shake hands with me, I would not shake hands his hands were full of scratches.
- q you could see them.
- a Yeş they were terrible, it was like raw beef, wide type scratches they were scabbed up obzy type things you don't put your hands on something like that.
